## **NOTICE OF ANNUAL GENERAL MEETING**

The breed society's Annual General Meeting will be held in the YFC Pavilion at the Stafford County Showground, Weston Rd, Stafford. ST18 0BG on Saturday 18<sup>th</sup> November 2023. (Building immediately on the Left once through the gate). The meeting will commence at 10.00am with complimentary tea and coffee available from 9.30am

Please note the English Winter Fair is taking place at the showground on this date. We have been advised by Stafford Showground that people must hold a valid ticket to enter the showground on that day. On production of your ticket, the Society will re-imburse you £12 per flock at the AGM (the price of an advance ticket).

We expect the AGM to finish around lunchtime giving members plenty of time to visit the show.

## **New Council Members**

We have vacancies for at least three breed society members to join the SSBA's Council from the AGM on 18th November. Nominations for Council are, therefore, requested. The period of office is three years. Over the past two years we have held a combination of Zoom meetings and face to face meetings, averaging one meeting per month, and this mix of meetings is likely to be the continuing trend.
